# **County Health Rankings**

## A Moment with the Executive Director

Each year, the Robert Wood Johnson Foundation, in partnership with the University of Wisconsin, issues the United States' County Health Rankings (CHR). The CHR highlight the health of our nation on a state-by-state basis, but also zero in on the health of individual counties, and show how county health relates to overall state health.

By ranking the health of nearly every county in the nation, the CHR help communities understand what influences how healthy residents are and how long they will live. These comparisons among counties provide context and demonstrate that where people live, and many other factors including race/ethnicity, can deeply impact a person's ability to live a healthy life.



The Rankings provide a snapshot of a county's health, and are used to drive conversations and action to address the health challenges and gaps highlighted in these findings.

This year, the Academy/DPHA was the lead entity for the distribution of Delaware's CHR. The 2019 CHS were focused on the intersection of housing and health, and we worked closely with the Division of Public health to get the message out.

Leveraging the impact of the CHR around a topic with which we can all easily identify can lead to an important and elevated discussion. It is only through the collection of quantitative and qualitative data around improved health outcomes that we can truly see a full picture of the health of our state and its counties. We invite you to participate in that discussion, and make sure everyone that needs a voice at the table can speak.



## The Delaware Academy of Medicine Annual Meeting!

The Academy's 89th Annual Meeting, Keynote Address, and Awards Ceremony will be held on **May 7, 2019**!

#### Join us!

Our keynote address will be given by David L. Heymann, MD DTM&H CBE. Dr. Heymann will discuss his career in global health and combating infectious disease. He will focus on the last remaining outposts of polio, and the importance of global polio eradication.

Dr. Heymann is Head of the Centre on Global Health Security at the UK's Royal Institute for International Affairs (Chatham House), and Professor of Infectious Disease Epidemiology at the London School of Hygiene and Tropical Medicine.



He has served in senior positions in the US CDC and the World Health Organization, including as WHO Assistant Director-General, and as Representative of the Director-General for polio eradication. Dr. Heymann has worked on infectious diseases worldwide, including in the smallpox eradication campaign (India); the Ebola outbreak in then-Zaire in 1976; Legionnaire's disease (Philadelphia); and leading the global response to SARS.

He received the Commander of the Order of the British Empire (CBE) in 2009; is a member of the US National Academy of Medicine and the UK Academy of Medical Sciences; holds 3 honorary doctorates; and has received the highest awards from the American Public Health Association and the American Society of Tropical Medicine & Hygiene. He is Editor in Chief of the APHA's Control of Communicable Disease Manual, the most widely used infectious disease text in the world.

On April 1, 2016, the Delaware Medical Orders for Scope of Treatment (DMOST) form went live, and was available to Delawareans with terminal diagnoses.

At the beginning of April, the DMOST form and program was transitioned to the Delaware Quality of Life Coalition. Public Health 3.0 builds on the past successes and provides a new focus where public health is no longer defined solely by the public health department and its traditional programs. The APHA Council of Affiliates (CoA) is seeking abstracts that describes the role of APHA Affiliates in working in the new landscape, of Public Health 3.0. Abstracts could address numerous topics including:

**Enhanced and broadened approach to public health practice** – e.g., examples of cross-sector collaboration/partnerships; new models of public health leadership (Chief Health Strategist Role); examples of collective action to address community challenges

Leveraging data and resources to address social, environmental, and economic conditions that affect health and health equity – e.g., examples of communities/organizations using data for decision making; initiatives that address upstream determinates of health; innovative funding models that support public health infrastructure and/or community-level engagement work

**Foundational Public Health Services** – e.g., exemplars of public health programs needed in every community for the public health system to work well in protecting people's health; exemplars of knowledge, skill, ability and systems infrastructure necessary to support effective and efficient governmental public health services; exemplars of innovative funding strategies for foundational public health services
