# **President's Message**

I welcome everyone to the first edition of the Academy/DPHA newsletter for 2022. The beginning of the year, unfortunately, seemed like a reprise of the last two years, with the Omicron variant dominating the scene. However, it does seem that we may be turning a corner as evidenced by falling new positive cases, percent of tests positive and average daily hospitalizations. COVID-related deaths (though increased) appear to be less than prior waves, with increasing numbers of fully vaccinated Delawareans and also on the decline based on state data from 01/15/2022 - 01/21/2022. A dashboard and access is included in the newsletter.



Oral antivirals for COVID have received emergency approval by the FDA. Weinstock et al published an article in the International Journal of Infectious Disease possibly linking symptoms of long-COVID patients to aberrant mast cells, thus suggesting possible therapeutics for this group. We seem to be turning the corner, but we have seen this before. Until the all clear is sounded, vaccination and mask wearing still seem like pretty sound advice to me.

But the work of the Academy/DPHA must go on, and despite cancellations and moves from in-person back to Zoom, the staff continues to deliver. New funding sources have been found and received or accepted for support of the important work on health care staffing in our state.

Our efforts to improve the health care of the persons with Intellectual and Developmental Disabilities (IDD) in our state has led Mr. Glbbs and our staff to include consideration for this population in our interactions with speakers. For example, the **Hoopes Medical-Dental Lecture** this year will be given at the end of March by Dr. Andrew Swiatowicz, DDS, a resident expert in the dental care of persons with IDD who will share his best practices. Our hope is that this can be done in person.

Mr. Gibbs and I are working with a group of local advocates, service providers and the State to secure funding for a pilot study to assess needs for residential services for persons with IDD in Delaware. Ongoing and more to come.

The well-received **Mini-Medical School** is back and will take place starting on 24 February through 31 March on consecutive Thursdays. More information on the lectures and registration is available in the body of the newsletter.

As I said, the work of the Academy/DPHA continues - improving the health of all Delawareans. Hopefully, the trend continues, therapeutics continue to improve, herd immunity is achieved and we get to the other side of COVID sooner than later. That work will be a lot easier. Until next time, good health.



# **National Updates**

## **COVID-19 Testing in Schools**

It takes four or more days from the date of

infection with COVID-19 for the first symptoms to be detected, which means that individuals of any age can be on school grounds for almost a week, unknowingly spreading the virus, potentially longer if they aren't showing symptoms.



Proactive and comprehensive testing will allow school districts to identify those who are infected and may be asymptomatic. Testing in schools is supported by government funds to help limit the costs for schools, is less invasive, and the most effective way to monitor the prevalence of COVID-19.
