From the Executive Director

The following was presented at the opening of the 93rd Annual Meeting

of the Academy/DPHA on April 26, 2023.

"As we gather here today, we are faced with some of the most significant challenges of our time, including the COVID-19 pandemic which appears to be in the rearview mirror (for now), healthcare and public health workforce shortages, and the urgent need to address systemic racism as a public health crisis.

Systemic racism has been a longstanding issue in our country, and very evident in health outcomes. The COVID-19 pandemic has shed light on the pervasive health disparities that have long existed in marginalized communities and communities of color, and racism has finally been recognized as a public health crisis, one that we must address head-on.



The pandemic has also highlighted the vital role that public health and healthcare professionals play in our society. It has exposed the vulnerabilities and inadequacies of our public health infrastructure; it has disrupted our healthcare system in unimaginable ways, and left us with a depleted workforce and a strained public health system.

As we work towards rebuilding our public health and healthcare infrastructure, we must also address the shortages themselves, especially those that were apparent before the pandemic. It is essential that we invest in our public health workforce, ensuring that they have the resources and support they need to continue the critical work of protecting the health and well-being of our communities.

The Academy/DPHA working to strengthen and invest in the public health and healthcare workforce with our Delaware Health Force Initiative. We are a recipient of American Rescue Plan Act funding for this initiative, as well as funding from HRSA with our partner the Public Health Management Corporation for both Community Health Worker infrastructure and a CDC funded initiative for more general public health infrastructure issues. Through all of these efforts, we have held high the banner of Dr. Swanson's two-year term as President, the needs of the IDD community, and more work needs to be done!

This year's annual meeting provides us with an opportunity to come together, to learn from one another, and to develop strategies that will enable us to rebuild our public health and healthcare infrastructure, address workforce shortages, and tackle systemic racism as a public health crisis. I am confident that through collaboration and collective action, we can overcome these challenges and emerge stronger and more resilient than ever before. "
