## **TIMTalk: Changing of the Guard**

#### Dear Colleagues,

One of the most important undertakings an executive director can undertake is preparing for the future. Over two years ago, the Board of Directors and I selected Dr. Kate Smith as my successor, and we began the process of preparing her for the role. I officially hand over the reins to Dr. Smith at the end of the year: the Academy/DPHA is in great hands with Dr. Smith, and I can't wait to see where she takes the organization next.

As I reflect on the past 16 years, a couple of major themes stand out...

First, I have been honored to serve with so many incredible board presidents and board members over the years. I have learned from all of you, and am grateful for your partnership in making the

Academy/DPHA the organization it is today. Second, I have been blessed with the support of many to be entrepreneurial and "daring" over the years. Times change, and so must we to remain relevant and have an impact. Third, it has been my honor as Executive Director to highlight outstanding members of Delaware's Public Health workforce, which led me to the creation of the Executive Director's Public Health Recognition, an award complimenting the Academy/DPHA's Lewis B. Flinn President's Award, and which is now given out each year to a public health institution in Delaware making great strides to work for public health in Delaware.



- Sunset our library services business line, which had been tremendously altered by the "rise of the
  internet." While this move was extremely sad, it was a necessary move for organizational survival.
- Lead the charge in becoming Delaware's affiliate to the <u>American Public Health Association</u>, and made good on our commitment to furthering public health in Delaware.
- Created and published the <u>Delaware Journal of Public Health</u> now an internationally read and recognized publication! The DJPH is cited often in other peer-reviewed publications and used as training material in local institutions of higher learning. The Journal is now <u>PubMed</u> indexed, open access, and free to all (both readers and authors who pay no fee to publish their work).
- Formed strategic, mutually beneficial partnerships with other nonprofit organizations throughout
  the State and region, including the <u>Delaware Nurses Association</u>, <u>Public Health Management</u>
  <u>Corporation</u>, and its <u>Delaware Public Health Institute</u>, and more recently with the <u>Sussex County</u>
  Health Coalition and Tech Impact's Date Innovation Lab.
- Continuously operated <u>Delaware Mini Medical School</u> one of our most important health literacy and healthcare workforce feeder initiatives. Shown below is a picture from 2013, with just a handful of the hundreds of high school students who have participated in Delaware Mini Medical School.





- Maintained partnerships with long-standing allies including <u>ChristianaCare</u>, the <u>Delaware</u> <u>Healthcare Association</u>, the <u>Medical Society of Delaware</u>, and <u>Nemours Children's Health</u>.
- Joined with the <u>Maryland</u> and <u>Pennsylvania</u> Public Health Associations to create the <u>Mid-Atlantic</u> <u>Public Health Partnership</u>.
- Supported legislation in Dover that enabled 16 DE Admin. Code 4304 Delaware Medical Orders for Scope of Treatment (an end-of-life planning tool); supported S.B. 1 - Healthy Delaware Families Act – Family and Medical Leave Program; supported legislation which banned indoor vaping and other, related hazards; and our current work in partnership with the Community Health Workers Association of Delaware for enabling legislation to be introduced in the Spring 2024 legislative session.
- Formed the public-private <u>Delaware Health Force</u> Partnership with the State of Delaware an
  initiative I will devote my full attention to starting in January 2024. Delaware Health Force is about
  building and maintaining our healthcare and public health workforce and infrastructure, which is
  more important than ever after the pandemic.

In my 16 years at the helm, the Academy/DPHA has received the American Public Health Association's "Affiliate of the Year" award in 2020, and just this year we were awarded a Drexel LeBow 50 Data Analytics Award for our work on the Delaware Health Force.

It has been the honor of a lifetime to serve as executive director, and I thank you all for your partnership, friendship, and support over the years. Best wishes to Kate Smith as she assumes the role of executive director. I hope everyone will welcome her to the role!

Public health and medical services (e.g., patient movement, patient care, and behavioral healthcare) and support to human services (e.g., addressing individuals with disabilities and others with access and functional needs) are delivered through surge capabilities that augment public health, medical, behavioral, and veterinary functions with health professionals and pharmaceuticals. These services include distribution and delivery of medical countermeasures, equipment and supplies, and technical assistance. These services are provided to mitigate the effects of acute and longer-term threats to the health of the population and maintain the health and safety of responders.
